LEAGUE RULES

- 1. First team on schedule is the home team and keeps the game ball.
- 2. You need six (6) players of your own to play and can play ten (10) in the field. All four outfielders must be in the outfield grass. If there is deep dirt infield, players must be at least 60' from the pitchers mound.
- 3. Everyone bats that shows up. Continuous batting shall be in effect with free defensive substitution.
- 4. Coach pitches, umpire plays catcher, NO WALKS, level pitches, 2 spots to pitch from (encourage players to swing).
- 5. Games are six (6) innings or 1 ¼-hour time limit. An inning that is started must be finished.
- 6. Coaches can coach bases.
- 7. No leading off or stealing.
- 8. Game ends in a tie if tied at the completion of six (6) innings or 1-¼ hour time limit.
- 9. 3/4 OF THE WAY TO THE NEXT BASE RULE.
 - A. Umpire calls dead ball when ball is in 8' circle.
 - a. Return player to base if not 3/4 of the way to the next base.
 - b. Line on 3rd baseline determined 3/4 of the way to home plate.
