Mayor LeBlanc described the purpose for the hearing which is to receive public comments regarding the following City Code Change: Revision of the Silver Bay City Code Chapter 3, Licensing and Municipal Regulations, Section 345 Mobile Food Trucks/Vendors, Section 345.03 Applicability.

City Administrator Fralich summarized the proposed code revisions that no mobile food truck parked on public streets or property will exceed 32' in length (overall length for a self-propelled vehicle; trailer length including the towing vehicle for self-contained trailers) or 10' in height. Mobile food trucks in excess of 32' in length may park on private property by special use permit, provided all zoning and setback requirements are met.

Mayor LeBlanc called the public hearing to order at 7:00 p.m.

Mayor LeBlanc described the purpose for the hearing which is to receive public comments regarding the proposed vacation of Midbrod Circle and a portion of East Lakeview Drive located in the Silver Bay Business Park Plat and legally described as: all of Midbrod Circle, as platted and dedicated in Silver Bay Business Park according to the recorded plat thereof, Lake County, Minnesota and that pan of East Lakeview Drive, as platted and dedicated in Silver Bay Business Park, according to the recorded plat thereof, Lake County, Minnesota lying Southwesterly of a Line A, as described below and lying Northeasterly of Line B, as described below as its Southeasterly extension Line A: Commencing at the Northeast corner of Lot 1, Block 6, said Silver Bay Business Park, thence South 0 degrees 33 minutes 50 seconds West assumed bearing, along the East line of said Lot 1, a distance of 641.50 feet to the point of beginning of Line A; thence North 57 degrees 57 minutes 07 seconds West 99.13 feet to the Easterly line of said Lot 7, Block 5, said Silver Bay Business Park and said line there terminating. Line B: commencing at the most Northerly corner of Lot 2, Block 6, said Silver Bay Business Park, thence South 37 degrees 11 minutes 18 seconds West, assumed bearing, along the Northwesterly line of said Lot 2, a distance of 160.76 feet to the point of beginning of Line B; thence North 57 degrees 17 minutes 30 seconds West 66.20 feet to the Southeasterly line of Lot 6, Block 4, said Silver Bay Business Park and said line there terminating.

Mayor LeBlanc explained that the Council will open the hearing up for public comments, take comments, and then adjourn the Public Hearing. The Regular Meeting will immediately follow the Public Hearings at which time the City Council will accept or deny.

A map of the proposed vacation was shared on screen. City Administrator explained the map of property that is proposed to be vacated.

Mayor LeBlanc called for public comments.

Karen Rautio asked what the meaning of vacating is, it was explained that vacating a property takes away the public right of way and property becomes a privately maintained street.

Karsten Hogenson presented comments regarding when property had been gated in the past and during the winter season the roads are very slippery and vehicles are unable to make it up the hill without four-wheel drive. His also stated concerns about more people staying at the new development which would create driving problems during the winter months. He also expressed concern for the City's ability to maintain the remaining city road. There was discussion on snowplows access through the private road area, parking areas for plows to turn around, and emergency vehicle use.

Donald Carlson asked how Midbrod Circle got its name, Mayor LeBlanc stated it he believed it was named after Rule Midbrod with Karsten Hogenson confirming.

Mayor LeBlanc called for any additional public comments. There were no further comments.
