Mayor LeBlanc called the meeting to order at 9:05 a.m.

Agenda - Motion by DeRosier, second Bautch to approve the agenda with the revision of addressing the FAA Entitlement Funds Transfer to City of Owatonna prior to discussion of the Firewood Bid. MOTION CARRIED.

FAA Entitlement Funds Transfer to City of Owatonna - The FAA has \$450,000 of entitlement funds earmarked for the City of Silver Bay airport. The City has transferred these funds in the past in an effort to keep the entitlement funds local or within the State, instead of them going back to the federal pool if unused. Ron Roetzel, Bolten & Menk, discussed how the funds will be used, timing of the repayment of the funds to the City if a project is identified, and that this does not obligate the city for payback of the funds since the city transferred them instead of using them. There was question if transferring the funds would cause any issues for our pending airport situation with the FAA. Motion Hoff, second Bautch to transfer FAA Entitlement Funds of \$450,000 to the City of Owatonna for their use at their municipal airport for project improvements as presented with reimbursement of the funds in future years upon request, but to not to sign any agreement until the City Attorney has reviewed and authorizes the signatures. MOTION CARRIED.

Award of Firewood Bid and Contract for Black Beach Municipal Campground - The RFP submitted to bidders that details the species of wood, bundle requirements and a summary of bids was reviewed. Carpenter reported that he requested each bidder provide a sample of their firewood bundles to compare the wood quality, uniform size, and secure wrapping. He surveyed staff and the majority of the staff chose Singleton's firewood bundles, who also came in with the lowest cost based on a 3-year contract. There was further discussion on cancellation of the contract if issues arise, managing product to insure product remains consistent to the submitted bundle, and that the cost of \$3.25/bundle for 3-year would not be amended without approval. Motion DeRosier, second LeBlanc to award the Firewood Contract for the Black Beach Municipal Campground to BK Singleton Trucking for a 3-year term in the amount of \$3.25 per bundle as presented. MOTION CARRIED.
