**Consent Agenda** – Motion Perfetto, second Hoff to approve the minutes of August 6, 2018 Budget Workshop Meeting, the August 6, 2018 Regular Council Meeting and the August 13, 2018 Special Council Meeting. <u>MOTION CARRIED</u>.

# Petitions, Requests and Communications

**Lake Superior Magazine's Best of the Lake:** The Council reviewed the letter awarding Black Beach as the 2018 Best Sandy Swimming Beach from the readers of Lake Superior Magazine.

Heart Safe Community Designation – The Council reviewed a letter from Lake View Hospital and Lake County Ambulance Services inviting the City to participate in an initial meeting to help obtain a Heart Safe Community Designation. The program was formed by a partnership between the Minnesota Department of Health and the American Heart Association to promote community awareness of the potential for saving lives of sudden cardiac arrest victims through the use of CPR and increased access to defibrillation. The first initial meeting is planned for September. Perfetto will plan to attend that meeting. Fralich will check with DeRosier and Goutermont to see if they would also like to attend.

# **City Administrator**

Resolution 2018-#29 Bolton and Menk, Campground Engineering: The Council reviewed the resolution and proposal for professional fees related to the development, geotechnical, wetland, and testing services that will be paid on an hourly basis not to exceed \$267,329 for the development of the campground. The City was awarded for funding in the amount of \$1,765,000 in the 2018 Bonding Bill. Per DEED, the City can begin expending funds June 1, 2018 but the funds would not be reimbursed until the grant agreements are signed. The Campground Committee is recommending approval. Motion Hoff, second Johnson to adopt Resolution 2018-29, Approval to Execute a Contract with

Bolton and Menk, Inc. for Engineering services for the Development of Black Beach Municipal Campground Project.

Airport Response Letter – Council reviewed a letter from Cassandra Isackson, Director of MnDOT Aeronautics, a letter from Kevin Willis, Director of FAA Office of Airport Compliance and Management Analysis, and a response letter that was reviewed by the City Attorney. Motion Perfetto, second Hoff to send the response letter to Casandra Isackson, Kevin Willis, and to local legislators. Discussion on the importance of sending letter for public clarification. Fralich stated Kevin Willis did contact her via phone and he plans to help find a solution. MOTION CARRIED.

**Police Patrolman Hiring** – The Police Chief, Interview and Personnel Committee are recommending the hiring of Nicholas O'Toole to fill the vacant full-time police officer position pending a successful completion of a background, psychological and physical checks. Motion Perfetto, second Hoff to approve the hiring of Nicholas O'Toole starting at 80% of the full-time wage. MOTION CARRIED.

Reunion Hall Rental Form: The Liquor Commission is recommending a revision to the rental form for the Reunion Hall changing the no-fee section to a \$100 minimum floor care fee. Motion by Perfetto, second Hoff to revise the current form. Discussion on current Reunion Hall rental prices, concerns of increasing prices preventing rents, and the need for more use of the building. Fralich will look into what other area facilities are charging for building rent. MOTION CARRIED.

Wilderness Products Lease Amendment – Council reviewed the revised lease amendment to change the amount of the monthly rent payment, but not changing the amount due for the year from the previous amendment. The Mary MacDonald Committee recommends the revision. Motion Perfetto, second Hoff approve the revised lease agreement. MOTION CARRIED

Marina – Boat Shows – The Parks and Recreation Board recommends approval to send the Marina Manager to attend the Minneapolis Boat Show and the Duluth Boat show. Motion Perfetto, second Hoff to approve for the Marina Manager to attend the Minneapolis Boat Show January 24-27, 2019 at a cost of \$1625 plus meals and mileage and the Duluth Boat Show February 13-17, 2019 with an approximate cost of \$860 plus meals and mileage. MOTION CARRIED.

**Airport Lease Amendment** – Council reviewed the Airport Hangar Lease Agreement of Matthew Nelson to switch from hangar 11 to hangar 6. Motion Hoff, second Perfetto to amend Matthew Nelson's Lease Agreement. <u>MOTION CARRIED</u>.
