Beer, Liquor, Wine, and Cigarette License Renewals - The following license renewals for 2019 were presented: Zupancich Brothers, Inc - Cigarette License, Bri-Esa's Convenience Store - Cigarette License, Silver Bowl - Retail On-Sale Beer License, Northwoods Family Grille - Retail On-Sale Beer and Wine License, Silver Bay Golf Course  Retail On-Sale Beer and Liquor License, and Silver Bay Municipal Lounge – On and Off Sale Liquor. Motion DeRosier, second Hoff to approve the above Beer, Liquor, Wine, and Cigarette License Renewals. <u>MOTION CARRIED</u>.

Resolution 2018 - #44 – Transportation Alternative Funding – The Transportation Alternative Funding Resolution is required to submit the application for the Transportation Alternative Funding, which is due on January 4, 2019. The amount of the application is for \$600,000 and will be used for the Multi-Modal Trailhead Center. Lake County will be the sponsoring agency. The City should know if funds are awarded by the summer of 2019, prior to when submission for State bonding applications are due, but the Transportation Alternative Funds will not be available until 2023 if awarded. Resolution 2018 - #45 — Bolton-Menk Engineering for Trunk Sewer Line — Joe Rhein presented the preliminary engineering report for the trunk sanitary sewer line and the proposal to move forward with final engineering and design through bidding at an estimated cost of \$114,750 (with Geotech services). This cost does not include the construction management portion as this depends upon which construction option presents itself as the most cost-effective option following further engineering and design. Engineering for the project should be complete in order to have a better chance to obtain funding. The Public Utilities Commission recommends Council approval to continue with design and engineering of the project. Following the presentation, Joe Rhein answered questions presented by Council Members. Motion Hoff, second DeRosier to adopt Resolution 2018-#45 authorizing engineering services based upon Bolton & Menk's proposal for the trunk sewer line project at a cost of \$114,750.

The bonding funds were legislatively awarded this past session. The language in the agreement cannot be amended, but has been forwarded to the City Attorney for review.
