Resolution 2019 - #36 - General Obligation Sewer Revenue Note - The Resolution, drafted by Fryberger Law Firm, is to proceed with the \$250,000 General Obligation Sewer Revenue Note for the Sanitary Sewer improvements for the Wastewater Plant. The annual payment will be \$21,972.80 for the first four years and \$21,972.81 for the final year at a 3.22 percent interest rate and no penalty to pay off early.
