Consent Agenda – Motion by DeRosier, second Perfetto to approve the minutes of the June 19, 2017 regular Council meeting and the April 2017 Treasurer's Report. MOTION CARRIED.

Petitions, Requests and Communications

Legislator of Distinction – The Council reviewed a memo from the League of Minnesota Cities noting that Rep. Ecklund has been recognized by the League as a 2017 Legislator of Distinction. The Council acknowledged Ecklund's good work on behalf of the City.

Horn Boulevard Project Update – The Council reviewed an update from County Engineer Krysten Foster regarding this street reconstruction project. There was discussion about water line replacement under the boulevard, water shut offs during the project, and the timeline of the project.

MN Lottery Contract Renewal – The Council reviewed this annual contract renewal. Motion by Goutermont, second Perfetto to renew the contract with the Minnesota Lottery, for \$20, for lottery sales at the Liquor Store. MOTION CARRIED.

Resolution 2017-32 – The Council reviewed the wastewater facilities plan and noted the projects that need to be done, the cost of these projects, other possible funding sources, and the timeline of the PFA loan process. It was noted that a previous PFA loan is paid off, and a bond for the wastewater plant will be complete in 2018. Motion by Perfetto, second Hoff to approve Resolution 2017-32 authorizing to submit a point source implementation grant application to the Minnesota Public Facilities Authority and to authorize City officials to execute a grant application, for the wastewater treatment improvement project.

OLD BUSINESS - No old business was presented.

NEW BUSINESS

Mayor Johnson reported on a meeting that he and the Administrator had and with the MNDOT- Aeronautics about a needs assessment at the airport, including payback on FAA funds, repairs at the airport, use of the airport, and future plans for the airport.

Shopping Center Drive – Mayor Johnson reported on a recommendation from citizens about renaming the Shopping Center Drive the Zupanich Drive, in honor of long time businessmen Edward and Bernie Zupanich. The Council reviewed when this issue was addressed when a request came to rename the Golf Course Road. This issue was referred to the Public Works Commission.

Claims – The Council reviewed the paid claims list from July 3 and July 17, and noted items that were added to the unpaid claims list. Motion by Hoff, second Perfetto to approve payment of \$138,500.20 paid claims for July 3, \$127,881.95 paid claims for July 17 and \$41,256.82 in unpaid claims. MOTION CARRIED.
