Resolution 2017-15, City Code - The Council reviewed the revised City Code, and noted that all boards and commissions have reviewed the revised Code and recommend its approval, that a public hearing regarding the revised Code was held on November 21, 2016, and that the revised Code will take effect on April 1, 2017 after publication. City Permit Applications - The Council reviewed the updated permit applications, which coincide with the revised City Code. Motion by Perfetto, second Goutermont to approve the updated City permit applications, as presented, effective April 1, 2017. MOTION CARRIED.

AWAIR Safety Training – The Safety Commission recommends approval of this training. Motion by DeRosier, second Hoff to approve a contract with Advanced Minnesota to conduct the annual AWAIR safety training on April 19, for \$900.30. <u>MOTION CARRIED</u>. The MN Veterans Home, City of Beaver Bay, and area Townships will be contacted for participation by their employees, and sharing the cost of this training.

Seasonal and Part Time Employment – The Council reviewed the list of seasonal and part time positions. Motion by Perfetto, second Goutermont to approve the list of seasonal and part time employment positions and to advertise for these positions. MOTION CARRIED.

Police Chief Training – The Police Chief is requesting to attend the Police Chief's Convention, as part of his ongoing training, and it was noted that this item is in the budget, and that the Chief obtained some funding for the Police training that was approved at the March 6 meeting. Motion by DeRosier, second Goutermont to approve for the Police Chief to attend the Chief of Police Convention in St. Cloud on April 23-26 for \$430 plus 3 nights hotel for \$159 per night, and regular meals and mileage. Resolution 2017-16, Purchase of Fire Engine – The Council reviewed two bids from the bid opening on March 16, and it was noted that the Fire Chief and Street Superintendent have reviewed these bids for specification comparisons. Motion by Perfetto, second Hoff to approve Resolution 2017-16, awarding contract to Custom Fab and Body LLC for the purchase of a 2,000 gallon pumper-tender apparatus, for \$245,951.44.
