Black Beach Campground Ribbon Cutting Ceremony: The ribbon ceremony is scheduled for June 1, 2020 at 1:00 PM while maintaining social distancing. It will be recorded and posted online for others to view.

City Administrator

COVID-19 City Operations: Fralich discussed the plans to reopen city facilities with some limitations in the library, liquor store/bar, and city buildings. There was review and discussion of the new COVID-19 Preparedness Plan that outlines hygiene and respiratory etiquette, administrative controls for social distancing, housekeeping, prompt identification and isolation of sick persons, communication and training and that it was developed from a template recommended by the Center for Disease Control and MN Department of Health. Motion by DeRosier, second Goutermont to approve the COVID-19 Preparedness Plan as presented. Aye — DeRosier, Perfetto, Hoff, Goutermont, Johnson. MOTION CARRIED. There was discussion on how the number allowed in buildings was determined.

Prairie Fire Theatre Cancelled: The school advised that the auditorium will not be available for use for the Prairie Fire Theatre this summer, thus it is being cancelled. We have

requested an extension of the Duluth Superior Area Community Foundation grant for one year.

Summer Seasonal Employees: Members reviewed the part-time applicants hire list, positions, and wages. Start dates of part-time hires are up to the department heads. There was discussion for conducting BCA checks on applicants, the timing of receiving response from the BCA, the need to get applicants started, the delay of hiring due to COVID-19, if information on hires under the age of 18 would result in finding, and the cost of conducting the backgrounds. Motion DeRosier, second Perfetto to approve summer part-time hire applicants for positions of park aides, street aides, street mowers, flower trail, marina aide I and II, and library aide and that backgrounds will be conducted on all hires but immediate hires may start prior to receiving the BCA background check due to the timing. Aye – DeRosier, Perfetto, Hoff, Goutermont, Johnson. MOTION CARRIED.
