#### **Public Presentation**

MN 4-Wheel Drive Association - Dan Larson, Government Relations - Larson reported on the MN 4-Wheel Drive Association and the MN ATV Border to Border Touring Route that would start at the Multi-Modal Trailhead Center proposed in Silver Bay. He presented how the project got started, how they are working with the Lake County Commissioners, and how they have helped support the Multi-Modal Trailhead at the Legislature. Langness reported on the increased number of people joining the clubs and the need for the routes. Umphres reported on the work that is needed to complete the project.

### City Administrator

Police Sergeant Job Description and Internal Posting – Chief Kochendorfer is requesting to do an internal posting for a Sergeant position. The Personnel Committee reviewed this option, currently in the union contract, and is recommending it's approval. The City will not be adding staff, but it will allow for succession planning from a Police Officer, to Sergeant, to Assistant Chief, to Chief and have training to the various added responsibilities at each level. The change in pay is \$1.25/hour increase from a patrolling officer. Motion Goutermont, second DeRosier to approve an internal posting for a Sergeant position with a \$1.25/hour increase in wage as presented. DeRosier thanked the Chief for the thorough letter of reasoning behind the request. MOTION CARRIED.
