Housing Market Study – Councilor DeRosier presented information relating to a housing study being conducted by the Lake County HRA for the Silver Bay Area. The HRA is seeking funding support from the City to share in the costs to conduct the housing study by Maxfield Research. The study will emphasize the need for housing, the type of housing best suited for City needs, update a previously outdated study, and incorporate the area of the Silver Bay school district plus outlying areas, such as Tofte & Lutsen. The study will be used to support housing development and any future funding applications for housing within the City.
