Resolution 2018 - #38 Purchase and Development Agreement – Sophialee, LLC. – North Shore Adventure Park – The Purchase and Development Agreement is for the sale of City Parcel #'s 22-7401-32375 and 22-7401-32376 for the appraised value amount of \$12,000, along with the reconveyance of the MnDOT property C.S. 3807 (61=001)903 parcel 20, conveyance #2017-0016 in the amount of \$8,900, for a total amount of \$20,900. The agreement secures a 40' wide ATV trail and utility easement on the property, provides for compliance by new owner with MnDOT conditions, and has a revert clause if the property is not developed by 36 months. The revert clause is on vacant land because the restrictions on development are no longer in place as previously advised to the Council by the City Attorney. The Planning and Zoning Commission previously determined the sale was in compliance with the Comprehensive Plan. The Economic Development Authority recommends the approval of the Agreement and closing is set for on or before November 28th, 2018. Motion Hoff, second Perfetto to adopt the Resolution 2018 – 38, Purchase and Development Agreement with Sophialee, LLC for the sale of City Parcel # 22-7401-32375 and 22-7401-32376 and the MnDOT Parcel 20 for a total amount of \$20,900.
