Surplus Property – The Council reviewed a letter from Lake County transferring property of the Olympia Ice Resurfacer to the City. The Parks/Rec. Board recommend the sale of this item as surplus property and the sale amount to be taken off of the amount that the Blue Line Club owes the City for the new Zamboni Ice resurfacer. It was noted that this item will go out for public bid. Motion by DeRosier, second Hoff to declare the Olympia Ice Resurfacer as surplus property, with a \$10,000 minimum bid, and the sale amount to be taken off of the amount that the Blue Line Club owes the City for the new Zamboni Ice resurfacer. MOTION CARRIED. The Parks/Rec. Board recommends that the Thompsen Ice Edger be declared as surplus property. Motion by Perfetto, second Hoff to declare the Thompsen Ice Edger as surplus property, with a \$500 minimum bid. MOTION CARRIED.

**Resignation** – The Council reviewed an e-mail from James Lehn resigning from the Public Works Commission. The Council thanked Lehn for his service. Motion by Perfetto, second DeRosier to accept the resignation of James Lehn from the Public Works Commission. MOTION CARRIED.

Claims – It was noted that two claims for Neighborhood Revitalization Grants for 56 Law Drive and 28 Gibson, in the amount of \$500 each, were added to the unpaid claims list. Motion by Perfetto, second Hoff to approve payment of \$100,874.94 paid claims and \$48,775.13 in unpaid claims. MOTION CARRIED.
