Agenda - Motion by Goutermont, second DeRosier to approve the Agenda with additions of June 2021 Treasurer's Report and Sewer Jet Purchase. MOTION CARRIED.

Consent Agenda - Motion by Goutermont, second Bautch to approve the meeting minutes from the August 16th Regular Council meeting, August 23rd and 27th Special Meetings and June 2021 Treasurer's Report. MOTION CARRIED.

Petitions, Requests, and Communications -

Maker Market Events- Dan Cahill Matthews - Dan Cahill Matthews, Friends of Finland presented information regarding a Makers Market (similar to a Farmer's Market) with a request to use City Hall parking lot to test local interest beginning Saturday, Sept 11, 2021 9:00 a.m. - 1:00 p.m. and have 3-4 more events this Fall. Makers Market was previously held at North Shore Adventure Park area but received feedback that parking was a problem, so by moving it to City Hall parking lot they are hoping to generate more interest and continue with bigger events next year. There was discussion on the potential competition of business, potential use of the city hall for lavatories, licensing & insurance requirements, and who is responsible to confirm vendors have licenses needed. Costley will draft shortterm lease for vendors to sign. Consensus of the Council was that it is a great idea and a welcomed addition to the City. Motion by Goutermont, second DeRosier to allow the City Hall parking lot only to be used by Friends of Finland to hold Maker's Markets beginning Saturday, Sept 11th, 9:00 a.m. to 1:00 p.m. to continue this Fall and Council will revisit the request in the Spring to possibly continue in 2022. Engineering Services - East Lakeview Drive - Joe Rhein presented a proposal from Bolton & Menk, Inc. to provide engineering services for upgrades and reconstruction of East Lakeview Drive that has been identified to be funded through MnDOT and MnDNR. A grant to IRRR will be submitted to assist in the engineering funding, but a portion will be required by city. Motion by Goutermont, second DeRosier to accept the Bolton & Menk, Inc. proposal for engineering services for the reconstruction of East Lakeview Drive for an amount not to exceed

\$203,000 for engineering services, plus estimated geotechnical fees of \$15,000 for a total cost of \$218,000. MOTION CARRIED.

Memorandum of Understanding-Teamsters Local Union No. 346 – Council reviewed a MOU with the Teamsters regarding temporary changes with Police Department while in transition phase of hiring and training new officers. The city will first fill scheduled vacant shifts with the Chief and Part-time officers, and unfilled shifts will be offered to full-time officers in accordance with the union contract. Pay for experienced part-time officers will increase to current full-time rate of \$30.62/hr., retroactive to August 30th, 2021. If needed, Lake County can be contacted to fill open shifts and city will be invoiced. The MOU will expire when the Police Department is fully staffed and new hires have been trained or 6-months from signed MOU, whichever comes first. There was further discussion that this rate increase is for experienced officers who are working with other agencies that are assisting the city, and that new part-timers would remain at the current pay rate for part-time officers of \$21.79. Motion by DeRosier, second Goutermont to accept MOU agreement with Teamsters Local Union No. 346. Ayes: Bautch, Goutermont, DeRosier, LeBlanc, Absent: Hoff. MOTION CARRIED.

Motion by DeRosier, second Goutermont to approve purchase of new Wastewater Sewer Jet at cost of \$74,914 to be covered by Wastewater fund and to declare old Sewer Jet as surplus with trade in value of \$8500. MOTION CARRIED.
