Acting Mayor DeRosier called the meeting to order at 7:00 p.m.

<u>Agenda</u> – Motion by Hoff, second Bautch to approve the Agenda as presented. <u>MOTION CARRIED</u>.

<u>2023 Truth In Taxation Public Hearing</u> – The Acting Mayor DeRosier addressed the public that property valuations and allocation of taxes are completed by the County and that this meeting is related to the proposed budget and levy for 2023. Greg Swartwoudt and Ronnie Radle from Lake County were available in the Mayor's office to speak with residents regarding property valuations and allocation of taxes.

City Administrator provided a summary of the proposed 2023 Budget and Levy and noted that there was no levy increase, remaining at the same amount as 2022 of \$1,648,110.

Martha Chateleine questioned increases on the summary budget information included with proposed property tax forms and if streets within the city were going to be fixed. Thre was discussion on the lack of grant funding available for streets, that the city is working on how to finance streets, and that properties will have to be assessed.

Connie Strawhacker questioned if any progress was being made with the results of the community survey. EDA and Planning & Zoning committees are making plans and decisions based on survey results. She also feels that Silver Bay is not growing, property taxes are increasing and questioned why would residents want to stay.

Donny Thompson expressed his concerns regarding the golf course housing project and extension of water line, and suggested requiring an association type rule for homeowners; concern for added noise along Penn Avenue with the new housing development proposed; lowering the levy by increasing fees for programs and charge non-city residents hire to participate in programs as they don't pay taxes to maintain facilities; suggested to lower services to make it more affordable; feels there is no incentive for people to move to the city; how does state funding change for homestead vs. non-homestead properties; and questioned city snowplowing of church and school. City noted plowing was in exchange for use of properties for parking during events.

Erik Ollila stressed his concern regarding the rise in property valuation and taxes each year and what his options he has to contest these changes. There was discussion on going to the County Board, obtaining an appraisal to challenge valuation, and/or go to tax court.

Bruce Blanchard stated he is a new resident and asked for clarification on the Multi-Modal Trailhead project, impact on property valuation when neighbors have junk and blight conditions, and suggested charging parking fees for Black Beach and the Multi-Modal Trailhead areas.

City Administrator provided information on Homeowner Homestead Credit refund that is available to help with rising property taxes. Information regarding both refunds is located on property tax statements.

Gene LaFond and Phil Huston thanked the Council for their work.

Council thanked the residents for attending and for their feedback.

Connie Strawhacker thanked Council for listening to them.

All residents attending Truth in Taxation left meeting at 8:55 p.m.
