**Resolution 2023-#16 IRRRB Grant Amendment-** Council reviewed the amendment to extend the grant agreement with IRRRB for the Outer Drive Beautification Project, retroactive to December 31, 2022. Motion by Goutermont, second Bautch to adopt Resolution 2023-#16 IRRRB Grant Amendment. MOTION CARRIED.

Stormwater Management Plan Review and Draft Report- Joe Rhein and Derek Benoy, from Bolton & Menk, presented the draft Stormwater Management Plan for the City of Silver Bay that they have been working on in cooperation with the Lake County Soil and Water Conservation District. The plan has been funded thru a grant from the Lake Superior North One Watershed One Plan and a Star grant. The plan has been reviewed by the Public Works Board as well. They are asking the Council review

and make any recommended changes so the final draft can be approved at the March 20<sup>th</sup> City Council meeting in compliance with the grant agreement completion date of 3/31/2023.

**Summer PT Employment Advertisement** – Council reviewed the summer seasonal employment advertisement. No changes from 2022, other than the Library Aid was adjusted to match wages of other aides within the city. Motion by Goutermont, second Bautch to advertise for summer seasonal employment as presented. <u>MOTION CARRIED</u>.

**FT Police Officer** Advertisement- Chief Ernest is recommending advertising for the Full-time Patrolman position that has been open since last Summer. Motion by Goutermont, second Bautch to submit advertisement. MOTION CARRIED.

**Campground Host Advertisement-** Council reviewed the Volunteer Campground Host advertisement that is same as 2022. Motion by Bautch, second Goutermont to advertise for campground host and to also reach out to previously interested parties. <u>MOTION CARRIED.</u>

Costin Group, Inc. Agreement Extension- Jeff Anderson, Lobbyist for the city, provided an update on the status of bonding bills and funding in the current Legislative session. The agreement expired February 28, 2023, Council reviewed the agreement extension with Costin Group, Inc. at a rate of \$1250 per month until December 31, 2023. Motion by Goutermont, second Bautch to approve extension agreement with Costin Group, Inc. MOTION CARRIED.

East Lakeview Drive Tree Removal- Cleveland Cliffs has given its approval for the city to begin tree removal in the East Lakeview Drive project. There has been a regulation change to protect the Northern Long-eared bat and tree clearing will not be allowed during nesting season, April 1, 2023 to October 31, 2023. Council reviewed the planned tree clearing area. Work will be done by city staff. Motion by Goutermont, second Bautch for tree removal. MOTION CARRIED.
