Mayor LeBlanc called the meeting to order at 7:52 p.m.

<u>Agenda</u> – Motion by DeRosier, second Goutermont to approve the Agenda as presented. <u>MOTION</u> <u>CARRIED.</u>

<u>Consent Agenda</u> – Motion by Goutermont, second DeRosier to approve the meeting minutes from the July 17th 2023 Regular Meeting and May 2023 Treasurer's Report. <u>MOTION CARRIED.</u>

<u>Swearing In of Marcus Small, Full-time Police Officer</u>— Marcus Small was sworn in by Mayor LeBlanc as a full-time police officer with Silver Bay Police Department after successful completion of the conditions of employment. Parents Kris and Bruce Small pinned the badge on Officer Small. The Council congratulated and welcomed Officer Small to the City. Goutermont stated how nice it is to see graduates from Silver Bay come back and serve the community.

Petitions, Requests, and Communications -

East Lakeview Drive Bid Opening- Due to not receiving the State signed documents in enough time, the public bid opening has been rescheduled for August 29, 2023 at 11:00 a.m. at the Lake County Service Center in Two Harbors.

Mayor to Serve on Workforce Development Board- The Mayor has been approached to serve on the Northeast Workforce Development Board. There was consensus of the Council to support Mayor LeBlanc's nomination to serve on this board.

City Administrator -

Bolton & Menk-Boathouse Bay Review and Proposal for Construction Phase- Joe Rhein, City Engineer provided a review of the Boathouse Bay project, that there are no objections or further comments to the street vacation, lot splits for Lot 6, Block 4 and Lot 2, Block 7, Preliminary Plat, and Access Easement. He further discussed there was still comments being addressed to the Preliminary Public Utility Easement Map, Construction Plans, and Project Manual. Rhein further discussed three non-conforming items in the plans that he does not object to, identified additional plans the Developer will need to provide, and additional permits to be acquired, and that all of these items should be address in the Development Agreement. Rhein further presented a proposal for Bolton & Menk to conduct professional services during the construction phase of the project to oversee the public utilities portion is being installed according to the plans and specifications before Bolton & Menk would sign off on the acceptance of the installed utilities to become public utilities. The scope of services was reviewed, the items outside of the scope, and that their proposal cost for full-time services would be \$148,500. There was clarification on the proposal and a consensus of the City Council to table action of the proposal until all the documents of Boathouse Bay Development project are completed and approved.

Set Special Meeting for Boathouse Bay Action-August 17th- Motion by Goutermont, second DeRosier to set a special meeting on August 17, 2023 at 10:00 a.m. for the purpose to review and take action on the final Development Agreement, PUD, Preliminary Plat, Conditional Use, TIF, Tax Abatement, Lot Splits within the Bayview Park Plat, Vacation of streets, IRRR grant award, Bid Award, Bolton & Menk Construction Management Proposal, and any other items relating to the Boathouse Bay Development, and set another special meeting if needed. MOTION CARRIED.

Resolution 2023-#42 Bolton & Menk- New Road (behind Shopping Center) Feasibility Study-Council reviewed a proposal from Bolton & Menk to conduct a feasibility study on the new road proposed behind the shopping center. Motion by Goutermont, second DeRosier to accept Resolution 2023-#42 Bolton & Menk New Road Feasibility Study not to exceed \$29,000. MOTION CARRIED.
