OLD BUSINESS

Arena Update – Ice out is scheduled for March 14th; Garage door has been repaired and Carpenter is requesting yearly inspections. Equipment performed well all season; Zamboni battery charge continues to stay in the normal range so plan is to hold off on replacement.

Black Beach Campground- Reservations continue to come in, no problems with Campspot website. Discussion regarding construction season being an issue for campers, Carpenter reports high use by daily visitors to Black Beach area.

Programs- Carpenter attended the Arrowhead Softball meeting, registration has opened for baseball and softball. Discussion regarding coaching requirements and programs offered.

Senior Workshop Relocation- Carpenter attended the Multi-Modal Trailhead Center project meeting and there was discussion relating to the Senior Workshop building and possible location options to relocate them, the cost savings for relocating, safety, and benefits to having the Seniors at the school. Mayor LeBlanc and Carpenter met with school officials, Carpenter met with most Seniors who use the workshop, and all have been receptive. Carpenter will be in contact with leaseholders at the Mary Mac as an option. NEW BUSINESS -

MN Twins Field Grant for Mary Mac- Carpenter has applied for the MN Twins Field Grant in the amount of \$15,000 for improvements to the Mary Mac field. Application was due March 1st and currently in review.

Mary Mac Field Plan- Carpenter submitted proposed improvement plans for the Mary Mac field which include expanding infield, fencing, improve dugouts, adding bleachers, new sod and moving playground to have batting cage near field. Discussion regarding possible issues of back fence location, playground road, and parking. Further discussion regarding housing location, bus garage area, and re-using fencing and field dirt from soon to be demolished rec ballfield. No action was taken.
