Message from the Mayor

Greetings,

Fall and Winter is a favorite time of year for me. I enjoy seeing the kids back in our school, going to high school events, the fall colors, and the holiday seasons that come around at the end of the year. There is a lot to be thankful for in our small community.

The City continues to tackle the challenges of housing, workforce, road and infrastructure improvements, inflation, and tax impacts. Council and staff are working on the 2025 budgets and it is very difficult. There are things not in the Council's control, such as how your properties are assessed or what share of the taxes you pay, but there are things we can control. We will work hard to create a budget that meets our current needs while preparing for our future. Councilors are residents of Silver Bay too, and changes in the taxes impact everyone, so please know that we are trying to do our best to minimize that impact. The proposed budget and levy needed to be set by September 30th, which was done, but it is not the final budget and levy. The proposed budget and levy are what you will see on your tax statements prior to Truth-in-Taxation; however, we will continue to work on the final budget that needs be certified by December 31st.

East Lakeview Drive construction (the road to Black Beach) is, for the most part, complete. Constituents have asked why that road was done before other roads in the city. It is because there was special funding to improve that road that other city streets were not eligible for. The library construction is shaping up nicely, and I am crossing my fingers that the funding for Silverpointe II will be secured. Other updates on city projects will be found throughout the following pages.

When I look at our community, almost all facets of what makes up the infrastructure of Silver Bay is being addressed. There have been new businesses, new homes, our school and library getting renovated, Water and Sewer facilities being improved, updating of our recreation areas (black beach park, outdoor rink, and the rec center area), a new campground, roads and utilities, and sidewalks. Timing of when projects come to fruition are dependent on project support, funding (grants), and construction. In 2014, key stakeholder groups in the the City of Silver Bay community worked together to update the city's comprehensive plan and develop a vision for 25 years in the future. Through public process the vision was eventually adopted by city council in 2015; and, the result of this was the creation of a vision narrative, goals, objectives and implementation steps that provide a road map for moving toward this vision. The vision statement is in the blue box below.

The vision encompassed 8 areas which each have their own set of identified goals and objectives. The 8 areas are:

- Land Use
- Natural Resources
- Trails and Recreation
- Economy
- Transportation
- Public Services and Infrastructure
- Housing
- Cultural



- implementation of our citywide street and utility project

MN Homestead Credit

The homestead credit can provide relief to homeowners paying property taxes. To qualify you must:

- 1) Own and occupy a home
- 2) Have your home classified as a homestead with your county
- 3) Pay or arrange to pay your property taxes.

There are two types of Homestead Credit Refund:

- 1) A regular refund based on your income and property taxes,
- Regular: You owned and lived in your home on January 2, 2024. Your household income for 2023 was less than \$135,410.
- 2) A special refund based on how much your property tax increased.
- Special: You owned and lived in the same home on January 2, 2023, and on January 2, 2024. Your home's net property tax increased by more than 12% from 2023 to 2024. The net property tax increase was at least \$100. The increase was not because of improvements you made to the property.

Minnesota Cold Weather Rule



The Minnesota Cold Weather Rule is designed to protect people who may have trouble paying their utility bills in the winter. It applies from October 1st to April 30th. In the case of city utilities, this only applies to those who have hot water heat for their primary heat source. For more information on this rule, visit www.silverbay.com.

4th Quarter utilities payments are due December 31 at 4:00pm, either online or delivered to City Hall. Payments must be received by the City Administrator's office no later than 4:00pm.

Water, sewer, and garbage services are billed on a quarterly basis. Bills are processed and sent out in January, April, July, and October. Payments are due upon receipt.

City-Wide Street Improvement Project

The City has secured \$6 Million in funding to help support Phase 1 of our City-Wide Street Improvement Project. The total budget for Phase 1 is \$12M, which is needed to meet the 1:1 match for funding. Bolton & Menk, Inc., the City engineering firm, will assist the City to create the overall program for the City, including the creation of a Special Assessment Policy. They are also starting the preliminary design to collect the data, surveying, wetland delineations, proposed design, and cost estimates to help aid in decision making and planning. Sections A, B, and C of the map below is what will be included in the preliminary design for the first phase.

Once the preliminary design is complete, we will have a better understanding of how much can be accomplished within the \$12M budget before final design gets started. There will be public meetings and more information provided as it becomes available to gather your input and to meet the required process, per statutes.

Our initial schedule is for the repairs to begin in 2026 and be completed in 2027. Repairing of City streets has been a top priority of the constituents for years, and funding to get this accomplished is very difficult; however, we are fortunate for the support of our Legislators to provide ½ of the funding for this first phase to help us start making these improvements.

Multi-Modal Trailhead Center



As mentioned in the Spring Newsletter, there has been various challenges that have delayed the timing of engineering, but we continue to work through them and expect to bid the project this winter and start construction in 2025.

Initial work has started for the project. Trees have been dropped to accommodate for the Northern Long-Eared Bat mating season. Once we receive the signed confirmation from the funding sources and signed easement documents are obtained from Northshore Mining additional site prep work will happen.

The funding of the project has been secured through the Federal Transportation Alternative Funding, Environmental and Natural Resources Trust (ENTRF) fund through the Legislative-Citizen Commission on MN Resources (LCCMR), the State of MN Bonding, and the State of MN Department of Transportation.

Lake County CSAH Project

The road and utility project along Banks Boulevard (between Horn and Davis Drive) and Edison Boulevard (between Horn and Penn Blvd), known as CSAH, is a project that is going to be completed by Lake County in 2025. It should be noted that this is not part of the \$12M phase 1 City project, but the City-Wide Special Assessment Policy will apply to the CSAH area. Continue to watch for more information as it becomes available.



East Lakeview Drive & Black Beach Park

This project is 95% complete. We are working on improving the signage and some punch list items, but we hope you enjoy this improvement when traveling to Black Beach Park. The City has also received additional leased land from Northshore Mining to expand parking, trails, and primitive camping sites at Black Beach Park once we secure funding.



Housing

Silverpointe II Apartments

The City and Lake County HRA are working on securing funding for Silverpointe II apartments so we can continue moving forward with this project.

Boathouse Bay

Northland Constructors have started the extension of utilities for the Boathouse Bay development. Once completed, the city will have the needed utilities for the rest of the vacant lots within Bayview Park for future development.



Golf Course

The Planning and Zoning Board has been working on the zoning code for the Golf Course Housing Division, along with the review of the preliminary design for the development. A public hearing was held this week on the proposed zoning language. The Silver Bay EDA is acting as the Developer for the project currently. Sale of lots would start once all approvals are completed, which is unknown at this time.

Penn Avenue

The City has secured the property from Lake County HRA and is looking at a mix of multi-family and single-family units. The City will have three years to develop the property before the land reverts to Lake County.

Water Treatment Facility Upgrade

The City has been awarded \$1,750,000 of the \$8.2 Million project through the Federal Congressional Direct Spending Program thanks to Congressman Pete Stauber, Senator Amy Klobuchar, and Senator Tina Smith. The City is working with the PFA funding to help secure additional funds. The design and engineering have been completed and submitted to the State for review and approval of the upgrade to our Water Treatment Facility. This project will focus on reducing the uniquely high pressures in our system, adding a booster station, making improvements to the aging building, pumps, and other required components.

Construction Project Updates

Our expansion and renovation project is moving along nicely! The addition has been going up and you can see what the new space is going to look like. We are looking forward to all the things that will be happening soon in the newly renovated space!

We have moved to our temporary location, Room 9 of the Mary Mac building, for 4-6 weeks starting September 23. The closest entry is through the doors near the Lake County Service Center. We will be open our regular hours. Thank you for your patience during this transition.

We also continue to thank all the funding sources to help make this project happen, including the MN Department of Education, IRRRB, and Blandin Foundation, Otto Bremer Trust, Cliffs Foundation, MN Power Foundation, Lloyd K. Johnson Foundation, ALA Rural Libraries, Richard Smach Bequest, and various individual donations.

We are looking for volunteers to help us pack up and move back to the library building once the building project is finished. If you are interested in helping out please give the library a call and sign up at 218-226-433! We will take all the hands we can get.

Street Department

The Street Department purchased a new dump truck, pickup truck, and lawn mower this year. A new equipment lift was installed in our shop as well.

Reminders to residents:

- If you notice a street light that stays on or doesn't come on, please call City Hall at 218-226-4408 or the Street Dept at 218-226-4552.
- If you have a broken tree branch on your Blvd please call City Hall or the Street Dept. (Code 910.03 Subd. 1 and 5 prohibits pruning or tampering with boulevard trees).
- To avoid plugging storm drains, please do not rake or mow leaves into the street.
- No political signs are permitted in public rightof-ways or city boulevards (City Code 1230.01). Election signs are permitted in all districts, however, the signs shall be removed within 5 days following Election Day. No sign shall be placed on city or private property without the consent of the property owner or occupant.
- With winter fast approaching, please do not build snow forts in the snow banks next to the road or sidewalks.
- Please do not put your garbage cans on the street as we can not efficiently plow streets back to the curbs.
- Please note that no one shall deposit snow upon the property of another or into city streets or sidewalks (City Code 920.07).
- The City will not be liable for damage to personal property caused by City snow plowing or snow equipment when personal property is placed on the boulevard, street or sidewalk that is not readily visible to the operator of the equipment.

Department Updates

Utilities Department

As most people know, on August 19th we had a waterline break near the water treatment plant that resulted in a water emergency for the city. Our city crews worked hard and were able to fix the break. However, in an effort to prevent damage to our water system and get the system running as soon as possible the city issued a water emergency.

During this incident the water supply was never contaminated and remains safe to drink. The city used a variety of methods to inform the public including; direct phone calls, the city website, social media and the Lake County alert system.

The break was caused due to wear and tear on the pipes due to the high pressure of the water coming out of the plant. The city is in the process of adding a booster station to the system so that we can reduce the pressure in the pipes while effectively delivering water to the city. The water treatment facility improvements the street and utility projects are addressing our aging infrastructure. We will continue to do all we can to deliver safe and reliable water to the city.
