Public Comments- Tammy Alcaraz asked for clarification regarding when the Senior Workshop would be torn down, City Administrator Fralich that a date has not been set yet. Janey Knaffla questioned if the city was waiting for approval to move from the school. Ray Parker asked for information regarding senior access to school, hours, and keys. Tammy Alcaraz asked if the reports of vandalism at Senior Workshop has been addressed. Chief Ernest replied there has not been any reports received in the last year. Member Goutermont stated that he felt moving the senior workshop to the school is a good idea and hopes that students will connect with seniors as mentors.

John Anderson, Sawtooth 16, LLC provided an update on the construction at the Boathouse Bay Project. Project is moving along well, 1000 feet of water pipe to first fire hydrant is in place, reminded that Lakeview Drive is vacated now and does not want public going through there while construction is in progress. Tammy Alcaraz asked if residents and DNR were informed of blasting. City Attorney Costley reminded those in attendance to not interrupt those speaking, no debating or shouting.

It was noted that Section 551 relating to Unsheltered Storage was removed and not recommended for adoption. Chief Ernest stated key changes include process of abatement and cleanup of language to follow state statute regarding landscape gardening. Resolution 2024-#59 Nor-Son, Inc Contract Amendment for Change Order #2. Council reviewed change order #2 due to new lighting fixtures being unable to tie info the original mechanical system, which resulted in additional costs for new ceiling tees, diffusers, and registers at a cost of \$7,853.00, plus a change to repairs of the walls due to acoustic panels being removed, that this delayed decision was planned to see what type of repair was needed once removed, and that the cost effective repair was determined to be skim coating and patching at a cost of \$4,639.00 for a total cost of Change Order #2 of \$12,492.00, which is part of the contingency set aside. Councilor Hoff asked if the add on is truly needed, Library Manager Walz stated that they are needed and contractors are sticking very close to budget.
