**MN** Air National Guard Request for Use of the Airport- The MN National Guard has again requested to use the airport for a few hours to conduct training that would include use of helicopters and radios to conduct mounted and dismounted operations training. This is a full-time position with benefits. Starting wage is 80% of Human Resources & Payroll Coordinator full-time wage, 90% after successful completion of 6 months, and full wage rate after successful completion of 1 year probation. <u>MOTION</u> CARRIED.

The review identified key highlights such as the completion of the East Lakeview Drive and Library addition projects, starting of Boathouse Bay and Outdoor Rink projects, and continued work on Water Treatment Facility upgrade, the Multi-Modal Trailhead Center, Golf Course renovations, city-wide street improvement plan, housing, and many other programs and improvements. Mayor LeBlanc expressed his thanks to the public for attending meetings and their interest in the city.
