Public Comments- Marcia Oates expressed thank you to the City for the excellent communication regarding the recent water breaks in the City.

Mayor/Council Communication- Mayor LeBlanc stated that the city water break on January $26 - 27^{th}$ was an all hands on deck event. He expressed his thanks to city staff, police department, citizens in the community and MN Rural Water Association who pitched in to help. Mayor LeBlanc also noted that

the use of Social Media to spread misinformation does not help the community and he is available to speak with anyone who has concerns regarding the city.

MN Rural Water Association- Bob Klug and Ben Oseien, MN Rural Water Association provided information regarding the MN Rural Water Association, a nonprofit group that provides communities smaller than 10,000 water/wastewater support when needed, they also provide training free of charge, and technical assistance. They recently provided help to the city during the water breaks on January 26-27th. They commended the city staff, mayor, citizens who came together to help during the break. They expressed that the city is one of the best in the State to work with and to have five breaks with water shut off on only one section of a street was amazing. They are requesting a letter of support from the city to provide for federal funding to continue providing services to small communities. Motion by Bautch, second Hoff to send letter of support.
