OLD BUSINESS -

Wastewater Treatment SCADA- Brian Guldan of Bolton & Menk presented information and recommendations regarding the wastewater treatment SCADA improvements. Three quotes were presented with Automatic Systems Company coming in with lowest bid of \$149,470.00 base bid, plus \$52,891.00 for the addition of Alternate #1 which includes installation, replacing, and relocating the existing motor control center (MCC) to meet current electrical code, with a total combined bid of \$202,361.00. The cost for both the SCADA and MCC is for equipment only. Bolton & Menk are recommending awarding bid to Automatic Systems Company. Discussion followed regarding electrical contract work will need to be solicited to complete the electrical installation portion of project, the SCADA installation cost is estimated to fall in the range for \$10,000 to \$20,000, and the MCC installation cost is expected to range from \$30,000 to \$40,000. Further discussion followed regarding servicing of equipment and ability to lock in the price quoted. Motion by FitzGerald, second R. Bautch to recommend Council approve the proposal to Automatic Systems Company for a cost of \$202,361.00. MOTION CARRIED.
