Resolution 2025- #24 Ordering Improvement, Approving Plans & Specifications and Ordering Advertisement for Bids for the CSAH-32 Reconstruction Project- Josh Stier, Bolton & Menk, provided information regarding ordering the improvement, approving plans and specifications, and ordering advertisement for bids. The bid opening for the CSAH-32 Reconstruction project, as the required next step to follow the Statute 429 assessment process, will begin April 16, 2025 at 1:00 p.m. This resolution allows Lake County to advertise publicly for bids on proposed improvements. Motion by DeRosier, second Bautch to adopt Resolution 2025-#24 Ordering Improvement, Approving Plans & Specifications and Ordering Advertisement for Bids for the CSAH-32 Reconstruction Project. <u>MOTION CARRIED.</u>

East Lakeview Drive Final Payment- Josh Stier, Bolton & Menk, presented a revised final pay application to council. The final pay amount is \$74,721.78 which is an increase from the draft version of \$39,845.68 presented in December 2024. The additional \$34,876.10 attributes to additional quantities for bituminous paving, aggregate class V, and costs associated with Change Order #6 for the additional ditching and rip rap stabilization work. All final paperwork has been provided by Ulland Brothers with the exception of the Warranty Bond. Motion by Bautch, second DeRosier to recommend approve final payment of \$74,721.78 to Lake County for the East Lakeview Drive improvements pending receipt of Warranty Bond. It was noted costs for project were within budget. <u>MOTION CARRIED.</u>

RFP for Hydrants- The city has an opportunity to purchase hydrants at a discounted cost and the PUC is recommending Bolton & Menk create a quote package to obtain pricing form local suppliers per state requirements. Motion by DeRosier, second Bautch to approve Bolton & Menk solicit quotes on behalf of the City. <u>MOTION CARRIED</u>.

Senior Workshop Surplus Items- Council reviewed items from the senior workshop to be declared surplus either by donation to the school for the new senior workshop area, transferred to other departments, bid sale, or obsolete. Motion by FitzGerald, second Bautch to declare the listed items as surplus. <u>MOTION CARRIED.</u>

City of Beaver Bay request for Police Assistance- Council reviewed a request from the City of Beaver Bay for use of the Silver Bay Police Department to conduct background checks for preemployment with the City of Beaver Bay. Discussion followed regarding liability issues, why Lake County wouldn't do, options for BCA backgrounds, and what exactly Beaver Bay expects in a background check. Consensus of the Council to table until more information is obtained. <u>MOTION TABLED.</u>

Sawtooth Mountain Cannabis LLC Lawsuit- A civil lawsuit has been filed against the city and referred to League of MN Cities to assign council. Julie Jensen asked for clarification on civil suit, Attorney Costley advised due to litigation Council is unable to discuss.
