Review & Designate Zoning District-Adult Oriented Business- City Administrator Fralich explained that while reviewing the city codes, zoning from Business Park to Bayview Park didn't account for Adult Oriented Business, and that the City Attorney asked that the Planning and Zoning determine the proper zone. Discussion regarding areas allowed, distance required from schools, definition of code, and previous location. Motion

by DeRosier, second French to table until City Attorney is present to provide legal advice. <u>MOTION TABLED.</u> Further discussion followed regarding ownership of land, having it as conditional use only, and that the consensus was for it to be in the zone (GI) General Industry.

Review of Chapter 11-Subdivisions & Review of Chapter 12-Zoning- City Attorney is asking P&Z to review redline and highlighted areas in Chapters 11 & 12. Discussion regarding clarification on procedure, hearings, changes to subdivision language for Planning and Zoning review on final plats, and land splits.
