# NEW BUSINESS -

**Bolton & Menk Lead Service Line Public Engagement-** Sarah Swedburg, Bolton & Menk provided information regarding the upcoming lead inspections to be conducted on behalf of the city. The State of MN is requiring all cities inventory both public and private water lines for lead and has provided grant funding to have Bolton & Menk conduct inspections and create an inventory to be entered into a data base. While inspections are being conducted for lead on properties prior to 1986. There will be information provided to the public during an informational meeting on August 25<sup>th</sup>, from 5:00 p.m.-7:00 p.m. at City Hall. Inspections will begin end of August to be completed by October 31<sup>st</sup>. Discussion regarding homeowners receiving letters stating water lines are "unknown", is most likely due to city owned lines being undetermined, and potential to obtain grants in the future to assist in remediation if lead pipes are found.

Mary MacDonald Operations & Capital Review- Set Joint Meeting- After review of information relating to operations and capital improvement needs, the Mary MacDonald Committee is recommending a joint work session to include Council, EDA, Mary Mac Committee, tenants, and interested residents to discuss the future of the Mary Mac building. Council reviewed survey responses of tenants, Revenue & Expenditures for 2024 through May 2025, an estimate from Jamar for repair costs of roof and walls, and financing received through MN Rural Water. Consensus of Council was to set a Special Joint meeting of City Council, Mary Mac Committee, and EDA for Monday, September 8<sup>th</sup> at 4:00 p.m. at the Reunion Hall.

<u>Claims</u> – Motion by Bautch, second FitzGerald to approve payment of \$412,963.66 in unpaid claims and \$547,305.21 in paid claims. <u>MOTION CARRIED.</u>
